Dear Parents/Carers of children in **Year 4**,

Arthog Outreach Wrekin Activity Day

We are pleased to inform you that we are offering an exciting opportunity for the **children in year 4** to take part in an activity day, which will be run by Arthog Outreach. Your child will be attending the trip on **Monday 17th March**.

This is a fantastic activity day run by Arthog staff, giving children the opportunity to engage in a meaningful learning experience beyond the classroom. It will help them develop teamwork skills and personal resilience while also enhancing the geography curriculum by focusing on map skills. Additionally, it will support their P.E. development as they use maps for orienteering under the guidance of experienced staff. Arthog Outreach allows young people to experience challenge and success in a caring and structured way in their local environment. Their time will be filled with new and exciting experiences. Young people learn new skills, improve attitudes and understanding, and develop their personal and social skills.

We will travel to the Wrekin via minibus and will leave school at approximately **9.30am**. We will aim to return to school for **3.00pm** therefore, we will be back in time for the usual end of school arrangements.

The cost of the visit will be £23.00 which goes towards the cost of the visit and transport. If your child would like to attend the visit, please give your consent, along with a **£3.00 deposit via ParentPay by midday on Friday 7th March**.

The remaining £20.00 will need to be **paid in full by Friday 14th March**.

Children will need a packed lunch and a drink (no glass bottles or fizzy drinks) which they will eat during the visit. **If your child is entitled to a Free School Meal** and you would like school to provide your child with a school packed lunch, can you please indicate on ParentPay if they would like a **HAM or CHEESE sandwich by Friday 7th March AT THE LATEST**. Alternatively, they may prefer to bring their own.

Please provide your child with a small lightweight backpack or carrier bag which is suitable for carrying their lunch and drink/s in on the day.



Please send children to school **wearing old clothes suitable for the outdoors** and bring a waterproof coat for inclement weather. We have attached a list of items from Arthog Outreach to help you.

Consent form and Acceptance of Risks

Please be aware that adventure activities themselves are not completely free from risk. Whilst the chances of serious injury are extremely remote the chances of minor injury (bumps and scrapes) have to be seen as possible outcomes to much the same extent as normal active play.

Please complete the Consent Form attached (we will also send a paper copy home) and indicate any information that may be relevant to your child on the course; this is very important and will not affect participation on the course.

If your child requires any medication, including travel sickness tablets, an inhaler/ EpiPen, please ensure this is taken with them by handing this to their class teacher and completing a medication form, which you can collect from the school office before the visit.
